



## DECOMMISSIONING

### Decommissioning / Deplant Planning

Where buildings are required to be reused, we plan and manage the decommissioning of services, decontamination of hazardous materials and substances and deplant of the processes with minimum disturbance to the ongoing operations at site.

## DECONTAMINATION

### Waste Characterisation / Decontamination Procedures

For complex demolition projects, i.e. in the pharmaceutical, nuclear, petro-chemical and offshore industries, we carry out robust waste characterisation surveys to help design the optimal decontamination and demolition works. This includes sampling and analysis of processes and facilities, design of decontamination procedures and monitoring of the actual decontamination works. Also included is the development of Site Waste Management Plans., Method statements and Risk Assessments.

## DEMOLITION

### Demolition Management

Once the decision has been made to close a site or demolish a structure, we provide a full range of management services to ensure that the works are carried out safely, on time and cost effectively. In addition we ensure that the works are carried out in compliance with regulations thus protecting clients from any liabilities. This includes developing the scope of works, tender documents, support on contract negotiations and supervision of the demolition contractor.

### CDM coordinator

As all demolition works come under the auspices of the Construction (Design & Management) Regulations 2007, a CDM coordinator is required to be appointed. **D3 consulting** employ a range of highly experienced CDM coordinators who will facilitate a safe completion for any type of decommissioning, decontamination, dismantling or demolition work.

### Divestment and Asset Realisation

Deciding on how to divest of a site, or a portfolio of sites, can be complex when comparing potential land value with works required to achieve the most advantageous land quality. **D3 consulting** provide input to the divestment decisions our clients will be making thus ensuring they get the optimum value from any land sales. This service includes costing scenarios for choosing whether to demolish the whole site or leave in place structures which can have a value to the potential purchaser. **D3 consulting** can also value scrap material on the site ensuring that clients achieve maximum credits from the demolition works.
